

HENRY GROUP ANNOUNCES SALE OF \$19.25 MILLION MULTIFAMILY ASSET IN DENVER'S WEST WASH PARK

DENVER, July 6, 2021 – Henry Group, LLC (Broker), as exclusive advisor to RW Flats, a Denver, CO LLC (Seller) and Urban Villages (Manager), is pleased to announce the sale of the fee simple interest in Vita Flats, to Cohen Rojas LLC (Buyer). This Class B Multifamily asset, located at 101 N Grant Street, Denver, CO 80203, closed on June 30th, 2021, for \$19.25 million dollars. Built in 1961 and renovated in 2009, Vita Flats is in the charming and densely populated West Wash Park neighborhood of Denver and sits at the southeast corner of 1st Avenue and Grant Street. "When we first acquired Vita Flats, the property was age restricted and in disrepair," said Jon Buerge, Chief Development Officer of Urban Villages. "We worked with the city to obtain a change of use and completed a full renovation to modernize the building and reposition the asset to align with the marketplace. We are proud of the value we created for the neighborhood and for our investors."

The 50,905 square foot building sits on a 15,625 square foot lot, and contains of Eighteen (18) Studios, Forty-seven (47) One Bedrooms, nine (9) Two Bedrooms, One-bath units for a total of 74 units. The 11-story building features a landscaped rooftop patio with unobstructed, 360-degree views of downtown Denver, the Rocky Mountains, and the Denver Tech Center. Along the first floor is a shared common area with a new Amazon package hub and a commercial-grade kitchen for resident use. The new owners plan on performing some additional renovations to the units, as well as potentially adding new units to the ground floor of the property. Patrick Henry, Boston Weir, Foster Gillis, and Tommy Vento of the Henry Group acted as transaction brokers in the successful completion of this sale.
